MAKING A DIFFERENCE Chalatz cites the medical malpractice case of *Nguyen v. Stecher*. The money damages helped meet the cost of cancer treatments for the widower whose medical coverage was lost with the death of his wife. Moreover, the trial generated evidence used by the state board of medical examiners leading to revocation of the doctor's license. "More than money, the family didn't want this to happen to someone else," Chalatz says. "That is what justice is all about."
